Finance charges will be assessed on all past due balances on the last day of each month.

MATERIAL RETURN POLICY
Effective 01/01/2012

North Georgia Brick Co., Inc. will not be responsible for over ordering. Your salesperson will be available to assist in takeoffs. However, the responsibility for material ordered ultimately rests on the purchaser. Variables such as job site conditions and different masonry contractors make exact takeoffs virtually impossible. North Georgia Brick Co., Inc. will not be responsible for ordering by 3rd parties. Please communicate with masons and superintendents the seriousness of excess material left on the job and the possible consequences to them.

Brick pickups that are not the fault of North Georgia Brick Co., Inc. (color change) will be made at the convenience of North Georgia Brick Co., Inc. Pickup request should be made with your salesperson.

Brick Pickups will be handled as follows:

1. No credit will be issued for over ordering.
2. Brick will be credited at \$100 per thousand for color changes.
3. Brick must be sitting upright, in its original condition and still strapped in its original banding.
4. There will be a \$150 pick up charge per trip.

Material Pickups will be handled as follows:

1. Non-brick items such as block, mortar, etc. will not be picked up or accepted as returns. Credit will not be issued for non-brick items.
2. Reusable concrete block pallets (NOT MORTAR PALLETS) can be returned to our yard for full credit. We will not pick up these pallets.

Material delivered in error by North Georgia Brick Co., Inc. will be picked up when job site conditions allow and given 100% Credit.

The enforcement of this policy will allow us to dedicate our delivery trucks to shipping your material within the time frame you request.
